Live Line Demo — UDWI conducts demonstration for Smithville

Education, Training, and Information is one of the 7 Cooperative Principles and a top priority for the UDWI team. Our co-op has had great success keeping employees and members safe through the completion of various training and educational programs.

Over the last few years, the UDWI team has provided public safety training and education to law enforcement, firefighters, EMC personnel, and dispatchers in and around its service territory. In 2018, UDWI developed its own training yard to host training for its own team and other co-ops in the area.

In January, three UDWI team members provided Smithville's crews with a "table-top" interactive activity to demonstrate the danger of high-voltage live lines, hazards that can impact a live line, and how to execute proper safety when working around live wires.

Our crews used a live line display during the event, which includes a small-scale representation of the equipment UDWI uses in the field. The training equips line workers with the knowledge of how to handle downed power lines and the series of steps they need to follow during an emergency.

The goal of this demonstration was to educate Smithville crews on the danger of interacting with the high voltage lines and safety protocols for accident prevention. This collaboration with local communications providers is a top priority to ensure the safety of all crews that interact with live electric lines.

Demonstrations are available for schools, local first responders, youth organizations such as Boy and Girl Scouts, and any other organization that would like to learn more about safety around electric lines. UDWI Fiber Partnership Updates

Smithville Update: The project continues to move forward as more members are provided with fiber to their homes. Members can take advantage of the early sign-up option for all future fiber locations by visiting www.smithville.com or calling (800) 742-4084 to pre-register for services.

Below is the status for the various phases: Stanford

- Phase 1 thru 4 Taking orders
- Phase 5 Still under construction, should be ready in early March for customers
- Phase 6 Currently being designed and will have some Make Ready when construction starts
- Phase 7 Targeted for 2024

SCI Construction Update: The fiber backbone for the Freedom West Zone is complete and the fiber cabinet is in place on Freedom Arney Road. This cabinet will serve as the source of internet service for the area. Fiber distribution construction is underway in the northwest corner along: Hoot Road, Sassafras Road, Straight Line Road, Ault Road, Dutch Bethel Road, Shepard Road, Clark Orchard Road, Harrington Road and others. We anticipate drops starting in late spring 2023 for this area. Crews will soon begin distribution construction near the Freedom area including Gentry Road, Gloryville Road, Strouse Road, and Big Four Road.



Early registration is encouraged to help expedite the construction and drop process! If you are interested in receiving fiber internet service, please register as soon as possible at **join.sciremc.com**.
