## **Giving Back: UDWI REMC Community Fund**

The UDWI REMC Community Fund, Inc. is a non-profit organization created in 2004 by the cooperative to provide members with an avenue to make a difference in their communities. The program allows members to round up their energy bills to the next whole dollar to generate and maintain the fund. Every quarter, nonprofit organizations located in the UDWI service territory have an opportunity to apply for a portion of these funds. The UDWI REMC Community Fund, Inc. Board of Trustees review the submissions and issue grants accordingly.

In 2022, the Fund distributed over \$55,000 to local nonprofits across 40 charity organizations, and 27 so far in 2023. To date, \$1,066,000.00 has been donated to local nonprofits!

One such organization, the Lyons Community Food Pantry, received a grant in June. This organization aims to help those in need by providing food items to the local community. The pantry receives donations from churches, local nonprofits, and residents.

The grant will be used to purchase food items to stock their shelves. The pantry runs on a grocery store model of distribution where recipients select the items they need based on the size of their household. Recipients can shop for food supplies twice a month.

A food pantry volunteer told UDWI they noticed the difference the organization was making and wanted to help. They recognized the increased cost of food and how difficult it can be for families to make ends meet and wanted to make sure that no child goes without food.

Started in a church basement, the Lyons Community Food Pantry outgrew its original location and now operates from the former town fire station. Distributions are held the first Saturday of every month from 9-11:30 AM and on the third Monday of every month from 3-5:30 PM. The pantry serves residents of Lyons and Switz City. Recipients are not required to enroll; the pantry is free. The organization is always looking for donations and volunteers. Anyone interested in helping may find contact information for the pantry at the bottom of the page!

As we head into this holiday season, UDWI encourages its members and employees to give back to our community in any way that works best for you. Whether you can volunteer or donate to a local food bank, participate in a toy drive, or round up your electric bill to donate to the Fund - anything you can give back makes a difference! The Fund is now accepting applications for its next grant cycle. All nonprofit businesses in our service area are encouraged to apply! Please visit our website to learn more about the program and to start an application - the submission deadline is November 29.

### Qualifications for UDWI REMC Board of Directors

Three candidates will be elected at the 2024 annual meeting. **Districts 5, 7, and 8 are up for election**. Candidates will be elected to serve a three-year term.

Interested candidates must contact the UDWI office to receive a candidate packet.

Completed packets must be turned in on or before Wednesday, January 24, 2024.

To be eligible to become a director of the REMC, a person must meet the following qualifications:

1. Must be a member of the cooperative;

2. Must be a bona fide resident in the district which he/she is to represent;

3. Must not be in any way employed by or financially interested in a competing enterprise or business selling electric energy or supplies to the REMC, or a business primarily engaged in selling electrical or plumbing appliances, fixtures or supplies to members of the cooperative;

4. Must not be a close relative of an incumbent director or an employee of the REMC.
